12.2 Bell and Route Optimization

Chief Operations Officer Jeff Connel and Director of Transportation Desiree Fisher presented the information.

Board discussion included:

- Proposed bell times are available in the survey.
- Gratitude was expressed for the hard work involved with the presentation.
- Option A indicates 39% of the bell and bus routes have no change.
- Situation is urgent and need to consider impact on Steering Committee work.
- Important to note proposed changes are for one-year only; Steering Committee will make long-term recommendations.
- Early communication of decisions will benefit families who need to make changes.
- Driver crisis is critical and district cannot wait another year to fix the issue.
- Appreciation was conveyed for the work put in to the study, the context provided, the open conversation and problem solving.
- Rolling blackouts would likely be negative for attendance.
- A system that consistently exists in crisis is not sustainable.
- Previous school start time and bus route change occurred when district was in growth pattern.
- Employee retention is critical for success of the transportation program.
- Community in general is unaware of severity of situation; effective communication is key.
- Student access to education is crucial.
