

**SUMMARY:** Responsible for providing intake and making referrals for individual, family, and group mental health services to enrolled children and families in Early Head Start, Head Start and Pre-K. Serve as a team member to supplement school or district resources as they assess, refer, or intervene with students. Provide consultation to individuals and school and district teams, including reflective supervision for home visitors. Lead/Co-Lead or consult in professional development and parent education regarding mental health issues related to early childhood students, families, and staff.
