<u>SUMMARY</u>: Responsible for assisting the early childhood teacher with implementing instruction and/or reinforcing learning skills in one-on-one, small and/or large groups of children ages 3 - 5. Assist with preparing classroom materials, documenting student activities and progress, and supervising students.
