<u>SUMMARY</u>: Responsible for providing support and assistance to students experiencing behaviors and/or trauma so that they may fully participate in class and school activities. Monitor and reinforce pro-social skills, communicate with staff, collect data and work on special assignments as assigned by building administration.
