<u>SUMMARY</u>: Responsible for assisting the Career & Technical Education (CTE) teacher with coordinating and implementing the CTE program of work, including assisting in arranging job opportunities and interviews, job coaching, providing transportation to and from work sites and evaluating student progress/needs. CTE programming provides work experience, related classroom instruction, and post-secondary opportunities through concurrent enrollment and industry credentials.
