Current State: How Are SROs Connected to Key	Next step: N/A
Elements of Safety CAC members were invited to continue the work started last week on the different elements of their collective vision of safety. Working in Trello Boards, the goal was for the group to focus on elements identified as discussion points last week.	Decision: N/A
Groups were allowed to self select a Trello Board to join (Supportive School Culture, Direct Prevention, Preparedness and Response, and Recovery and Accountability). During an initial 20 minutes, the groups discussed the identified discussion elements and whether/how they relate to SROs. After 20 minutes, the group was brought back together and chose a second Board/topic to work on. An initial sub-group member stayed with the respective facilitator in the Trello Board room to give the next group an overview of what was discussed by the previous group. The second group was able to continue to refine and define the current state of safety and SROs in PSD.

The Community Engagement Subcommittee gave an update on their meeting the previous Tuesday. They are creating survey questions for a number of subgroups. They noted that while they dont think a survey is the best tool, given the time constraints it is what they are going to move forward with.

Discussion on SRO involvement

The facilitation team brought to the group the need for the group to engage in some substantial way with SROs or SRO representatives before making recommendations. They offered three different options for what that engagement could look like, and asked for others to be added. The final options were to:

- Have an SRO or SRO representative come to a CAC meeting for a Q&A session and to share their input
- Create a subcommittee to meet with an SRO, SRO representative, and/or the members of the SRO evaluation team that the district recently formed and come back to the CAC with their feedback
- Ask the Community Engagement Subcommittee to create a strategy to collect input from SROs
- Have an SRO or SRO representative come to the full group and allow those not comfortable to decide not to attend that portion

A discussion occurred:

- It was suggested that it shouldn't be just a random SRO but an SRO administrator or someone who knows the entire program
- Another member noted that they would like to hear from an SRO that works at every level of the schools - so perhaps three SROs to cover elementary/middle/high schools
- Another member mentioned they thought it would be important to talk to an SRO without a supervisor present so they can be more candid
- Another member noted they would like to meet with mental health professionals in the district
- PSD recommended starting with the FCPD as they are the most active. He suggested two individuals who oversee the program and could answer the group's questions
- One member asked if the group wanted to hear testimony from those who have had interactions with SROs
- A temperature check was taken on where the group would be if the SRO reps came to the next meeting and those who were uncomfortable were allowed not attend. The students raised questions about not feeling comfortable and the facilitation team agreed to follow up to come up with creative solutions to this.

Q&A on SROs and Mental Health Response.

- The facilitation team will follow up with the CAC student representatives on how to provide a safe way for them to participate in a discussion with SROs/SRO representatives.
- The Community Engagement Subcommittee will meet again next Tuesday

Decision: A CAC meeting will include an SRO representative.

Closing
