Olufunmilayo Garner spoke in favor of masks in school and being kind to others.

Lisa Maclean spoke on the poor accommodations PSD provides for people with medical exemptions and spoke against the masking policy in the district.

Heather Lahdenpera spoke on overcoming fear and working together for the benefit of the students.

Diana Majors expressed how PSD is robbing students of their education, and parents can make their own decisions on mask wearing.

Gina Forcatto spoke against masking in the district and the effects wearing a mask has on students.

Tasha Carr spoke against mask-wearing.

Casey Lindsey presented a parent statement concerning wearing masks in school, and students' removal from class for not wearing masks.

Erin Ramler came to speak on removing masks in school and the effect mask harassment is having on children.

Carly Rayburg came on PSD working with teens in mental health.

Malachi Gillespie came to speak on bringing more awareness to mental health in youths.

## 8.0 INFORMATIONAL REPORTS/DISCUSSION ITEMS

#### 8.1 Vision for Enhanced Mental Health and Social Emotional Wellness

Superintendent Kingsley introduced Director of Student Services Ruben Chacon, Mental Health and Prevention Coordinator Tyrell Hirchert, and students Akishita Bandi and Megan Jones, who spoke on mental health.

Board discussion included:

- Students are looking for more resources for mental health and ways to get immediate help.
- Students would like to see counselors check back in with them and let them know they are essential.
- Schools can have counselors, psychologists, or social workers as part of the mental health team. Each school has different needs.
- Mental Health positions are considered hard-to-fill, and the district could reach out to universities to find paid interns.
- Tools can be utilized to measure the skills students and staff have developed in SEL.
- Clarification was given on the funds for the program and where the district will use the money.

- A suggestion was given to reach out to community partners to advertise the programs available for student mental health.
- Working on multiple programs for the LGBTQIA+ communities.
- Mental Health Matters training for parents will be coming in the spring.
- Clarification was given on bullying and what the plan is.

Board recessed at 8:50 p.m. Board reconvened at 9:00 p.m.

# 8.2 Second Quarter School Resource Officer Presentation

Superintendent Kingsley introduced Director of Operations Matt Bryant and Assistant Superintendent Scott Nielson who provided an update on the School Resource Officer program.

Board discussion included:

- Clarification was given on the process of ticketing a student and when the district is involved.
- Data was requested on students who have been ticketed and the percentage who have gone through Restorative Practice and been successful.
- Clarification was given how an assault is classified.
- Clarification was given on the difference between teaching and mentoring.
