Poudre School District has not changed its stance on vaccinations; vaccinations are not required but are strongly encouraged. Poudre School District will continue to provide mobile vaccine clinics for staff and families. Parent consent is required for anyone under the age of 18.

#### 6.0 COMMUNITY COMMENT

Darius Bell asked a series of rhetorical questions regarding truth.

Eli Roth expressed concerns about the effects the quarantine process has on students with Individual Education Plans, specifically in reading.

Tasha Carr gave remarks on a political flyer passed out during the recent Board of Education election cycle.

Casey Lindsey expressed concerns about the mental health challenges that COVID is having on the children.

Aaron Green came to give remarks on the lack of representation for students with disabilities and the A.D.A. availability in Poudre School District.

Dani Lawrence came to speak on having a district-wide policy on quarantines. She asked the Board to please add Integrated Services to the agenda.
