Jeff Aufderheide spoke on political flyers sent out during the November 2021 Board of Education election.

Melanie Stockton read a letter from a PSD teacher about COVID-19 and the stress the regulations are putting on teachers and staff.

Jimmy Page expressed concerns with a lack of interactions with community members from the PSD staff at the Board of Education meetings and a lack of engagement with parents.

Bryan Blakely expressed concern that the current educational system is losing site on the purpose of the public-school education system.

Marc Fuchs spoke on behalf of the teachers who are afraid to come forward with concerns for their safety in school and the lack of consequences for students who are breaking the rules.

Jeannette Gaiter congratulated the newly elected BOE. She asked the Board to consider the 2019 CMAS reading scores and make changes to the current reading curriculum.

Heather Lahdenpera stated that schools are not back to normal and that the continued mask mandate is leads to many of the mental health problems in the schools.

Tracy Sorg read a testimony from a district school director about concerns about the mask mandate and how it is negatively affecting the children.
