To perform its duty with a governance style consistent with Board policies, the Board will follow an annual agenda which (a) completes a re-exploration of District Ends policies annually, (b) includes a review of all other policies annually, and (c) continually improves Board performance through Board education, self-monitoring, and enriched input and deliberation.

- 1. The Board shall review all Board of Education Policies, and make any revisions deemed necessary or appropriate, in accordance with the schedule set forth below.
- 2. The Board shall evaluate internal monitoring reports regarding District Ends ("DE") Policies and Executive Limitation ("EL") Policies as provided in Policy BSR 4.4, in accordance with the schedule set forth below.
- 3. Matters to be addressed by the Board pursuant to governing law, contract and/or Board or District Policy shall be included as an agenda item for timely consideration by the Board at the appropriate meeting.
- 4. Additional agenda items shall be determined for each Board meeting by the President, working with the Vice-President and Superintendent, as provided in Policy GP 3.4. Other Board members may request agenda items, which shall be added to an agenda if approved by majority vote of the Board.
