Confidential Student Record Information Collected/Maintained by PSD

Confidential student record information collected and maintained by PSD in its electronic data system that is not reported to the Colorado Department of Education includes the following:

- Student coursework, quizzes and examinations. These are used for students to develop and practice what they are learning in their classes and to demonstrate their knowledge by applying what they have learned, and for educators to evaluate student learning and receive feedback to assist in individualized student instruction. (Note that more specific student personally identifiable information regarding coursework, quizzes and examinations is provided in the lists of school service contract providers and school service on-demand providers posted on this website.)
- Student grades on coursework, quizzes and examinations. Grades are used to rate student achievement, track student performance and provide feedback for educators to assist in individualized student instruction. (Note that more specific student personally identifiable information regarding grades is provided in the lists of school service contract providers and school service on-demand providers posted on this website.)
- The results of end-of-course common assessments. These results are used to rate student achievement, track student performance, provide feedback for educators to assist in individualized student instruction, identify class trends in achievement and provide data for establishing teacher effectiveness ratings.
- Data collected and internal reports prepared by school nurses with respect to healthrelated services received by students through school health offices. This includes data and reports concerning the administration of medicine, administration of first-aid, administration of procedures for students on a healthcare action plan, immunization records and exemptions. This information is used to support PSD's ongoing provision of healthcare services for individual students, to preserve information regarding those services to share with the students' other medical service providers as authorized by law and to comply with legally mandated recordkeeping requirements.
- Intervention plans, and records of interventions and student progress, with respect to the application of PSD's multi-tiered system of supports in the areas of academics, social emotional learning and behavior. This information is used to systematically address individual student needs to facilitate progress in meeting academic, social and emotional goals.
- Information regarding student evaluations, placement, educational disabilities and related needs, special education, related services, behavior plans, accommodations, supports and goals specified in individualized education programs (IEPs); observations, data and other records related to student IEPs and PSD's special education program; all as conducted, determined, developed and recorded under the Individuals with Disabilities Education Act (IDEA).

- Evaluations, accommodation plans and related information concerning English language learner (ELL) students, which is used to determine ELL student needs and to provide appropriate accommodations and supports in connection with their accessing of and participation in curricular and extracurricular programs in PSD.
- Contact logs and information concerning homeless students and families served by PSD under the McKinney-Vento Homeless Assistance Act, which is used to determine the needs of homeless students and their families, to assist them in accessing available resources and programs, and to provide appropriate student accommodations and supports in connection with their accessing of and participation in curricular and extracurricular programs in PSD.
- Food allergy information, which is used to help ensure student safety with respect to food items served at school and school activities.
- Information regarding students' physical and mental impairments and limitations related to those impairments, which is used to determine disability status and to develop accommodations allowing students with disabilities to access PSD facilities and programs and to receive a free appropriate public education in accordance with Section 504 of the Rehabilitation Act of 1973.
- Information regarding individual students, student background and student behavior used by PSD to conduct student risk assessments and to develop student behavior plans and safety plans. This information is used to help ensure the safety of students and staff.
- Information provided to PSD as required by Colorado statute concerning petitions filed in juvenile court alleging specified offenses by PSD students, which is used to help ensure the safety of students and staff.
- Account balances for school food services and other goods and services PSD sells or loans to parents and/or students. This information is used to ensure accurate accounting regarding purchases.
- Parent eligibility for and election to receive PSD fee waivers. This information is used to ensure that indigent students are not improperly excluded from participating in specified PSD courses and activities and from purchasing specified PSD goods.
- Vehicle description, vehicle registration, insurance information, student identification and drivers' licenses regarding vehicles parked on campus by high school students, which is used to manage parking on campus.
- Student accident reports, which include information concerning student accidents that occur on District premises or during school-sponsored activities that occur off District premises. Accident report information used to investigate accidents and take appropriate

follow-up action, including steps to prevent similar accidents in the future, and if necessary to file claims with the District's insurance provider.

- Video, audio and audio-visual recordings at PSD facilities, in and around PSD buildings and on PSD transportation vehicles. These recordings are used to help ensure the safety of students, staff and members of the public, and the security of PSD property.
- Information regarding school buses which individual students ride, as well as the students' addresses. This information allows PSD to plan efficient student bus routes, and allows PSD and parents to track the location of school buses ridden by each student.
