<u>SUMMARY</u>: Responsible for providing senior level, district-wide vision, leadership, advocacy, and high-quality education to ensure effective special education programming for students with disabilities in Poudre School District. Ensure needs of students with disabilities are met through evidence-based, integrated, specialized instruction and services. Manage implementation of state and federal special education mandates, initiatives, and requirements including the Individual with Disabilities Education Act (IDEA) and Exceptional Children's Education Act (ECEA) and assure effective collaboration with all district departments and services. Responsible for oversight and management of staff, budgets, state reporting, and strategic and proactive litigation mitigation.

ESSENTIAL DUTIES AND RESPONSIBILITIES: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Description of Job Tasks

- 1. Develop, implement, and integrate the vision and leadership for year round district programming for students with special education needs in PSD. Serve as a district resource regarding special education issues, legislative and case law changes, and current relevant pedagogy and best practices for educating students with disabilities.
- 2. Partner with legal counsel and district leadership in interpretation and administration of local, state, and federal statutes, rules, policies, and administrative directions related to Special Education programs.
- 3. Direct department vision, mission, goals, and ongoing plan for data-driven continuous improvement.
- 4. Oversee state and federal reporting and compliance for special education including data collection, preparation, and submission for federal, state, and local monitoring and reporting related to IDEA and ECEA.
- 5. Collaborate with departments and leaders across the district to coordinate the development, implementation, and review of Special Education services. Assist with long range planning for integrated student support, including UIP development and use of the learning environment in buildings/sites.
- 6. Coordinate relevant professional development for licensed and classified Integrated Services staff and families.
- Coordinate data analysis and program evaluation for planning and improvement to ensure fidelity of programming for students with disabilities.
- 8. Set staffing levels for school special education programs to provide services with fiscal efficiency and program fidelity. Collaborate with Human Resources on staff allocations, assignments, personnel, and staffing issues.
- 9. Plan, submit, and oversee all department budgets, including special education operating budgets, staffing budgets, and state and federal funds.
- 10. Develop proposals for new programs, budgets, and grants for the purpose of meeting District goals in collaboration with the Learning Services Team and building/district leadership.
- 11. Recruit, hire, train and ensure effective supervision of integrated services staff including, Director Assistant Directors, Program Coordinators, Coaches, Professional Practice Experts, and central office staff.
- 12. In conjunction with legal counsel, provide direction on resolution of disputes, complaints, and due process.
- 13. Model effective collaboration, interpersonal and problem-solving skills, and conflict resolution for staff, students, and families.
- 14. Represent PSD's Integrated Services Department at local, regional, and state meetings, task forces and other functions. Ensure Integrated Services staff participation on state committees as appropriate.
- 15. Perform other duties as assigned.
- 16. Attend work and arrive in a timely manner.
