<u>SUMMARY</u>: Responsible for greeting and providing customer service to visitors (including district employees) at the Information Technology Center (ITC) building and answering and routing calls transferred from the District's main phone line. This position performs a wide variety of clerical duties for the Information Technology Department and other departments within the ITC. Duties include but not limited to, data entry, creating, editing, distributing, and filing records, correspondence, and spreadsheets, maintaining files, and operating office equipment, along with answering phones, providing information, and making outgoing calls.
