<u>SUMMARY</u>: Responsible for serving as a resource to Integrated Services (IS) paraprofessionals in the Integrated Learning Supports/Students with Significant Needs (ILS/SSN) programs working with students who have significant support needs by providing support with strategies for students and staff in the ILS/SSN programs K-12+. This position is expected to maintain high levels of professionalism and confidentiality in all aspects of the job with students, parents, and staff.

1. Under direction from case manager or certified staff, provide demonstration and guidance to Integrated Services (IS) paraprofessionals through modeling and/or shadowing of interventions. Provide feedback to paraprofessionals on their implementation of strategies and interventions such as supporting inclusive practices in the General Education environment, implementing instruction, and reinforcing learning skills, adapting curriculum to individual student needs, monitoring and enforcing acceptable social skills, implementing daily and long-range lessons and activities to meet Individual Education Plans (IEP), behavior plans, and/or health care plans. Assist with implementing specialized occupational therapy and physical therapy programs and activities.	D	20%

Provide feedback to IS paraprofessionals on their implementation of daily living supports such as assisting students with personal care, social skills and/or self-awareness, transitions, restrooms, lunchrooms, etc. This also includes for those assisting students with fostering independence with personal health and hygiene, feeding, tube feeding, toileting, catheterization, and diapering. Lift, transfer, or transport students in wheelchairs. Use alternative language techniques such as sign language or assistive technology devices and adapt classroom materials for use by a student with a hearing or vision disability as needed.	D	15%
3. Engage in activities that promote communication and understanding between the case managers and IS paraprofessionals. Coach and mentor current IS paraprofessionals who may need additional support related to student needs and case manager partnership.	D	15%
