



KFA - PUBLIC CONDUCT ON DISTRICT PROPERTY

The following conduct by any person on Poudre School District Property is prohibited:

1. Any statement or action that disrupts or threatens to disrupt District operations, or that otherwise creates a nuisance, safety hazard or disruption on District property.
2. Interference with or disruption of a District employee's performance of his or her job duties.
3. Interference with or disruption of a District student's educational or extracurricular activities.
4. Interference with or disruption of any meeting of the Board of Education or meeting of District employees, regardless of whether the meeting also includes students, parents and/or members of the general public.
5. Interference with or disruption of any person's lawful use of District property in accordance with District policies and regulations.
6. Obstructing a driveway, parking lot, sidewalk, walkway, building entrance, hallway, elevator, stairway or any other place used for the passage of persons or vehicles without the authorization of a District official.
7. Damaging or destroying District grounds, buildings or facilities without the authorization of a District official, or threatening to do so.
8. Damaging or destroying any vehicle or other property belonging to the District or any person without the authorization of a District official, or threatening to do so.
9. Use or possession of any dangerous weapon, as defined in District Policy JIC1, unless expressly permitted by law or authorized by a District official. This prohibition shall not apply to on-duty law enforcement and security personnel who are authorized by law to carry a firearm and/or other dangerous weapons.
10. Violation of any governing law.
11. Violation of any applicable District policy, regulation, administrative rule or other directive, including but not limited to District Policy ADC (Tobacco-Free and Marijuana-Free District).

12. Failure to leave District grounds, buildings or facilities, or any location therein, when directed to do so by a District official or law enforcement personnel.

Any person engaging in conduct prohibited by this policy is subject to removal from the District's property and to criminal prosecution. Any person who has engaged, or whom District officials reasonably believe will engage, in conduct prohibited by this policy may be excluded from entering District property.
