

## **Boys & Girls Club Transportation Application**

For students attending Boys & Girls Club of Larimer County

If your student attends the Boys & Girls Club after school, you may submit this application to request transportation from your student's school to the Boys & Girls Club. (There may be other reasons to request alternative transportation such as daycare, split families, etc. In these cases parents may apply for alternative transportation by completing the Alternative Transportation Request Form.) Be sure to read the information below, carefully.

Please note: Transportation to the Boys & Girls Club is only available from certain schools.

Transportation is not provided from the Boys & Girls Club to the student's home or other location.

## **Application Process and Timeline**

- All requests are processed first-come, first-served and are based on the space available on existing routes. (Note: Transportation Services cannot change bus stops or routes in order to accommodate requests.)
- Transportation Services will accept applications beginning June 1, 2018, for the 2018-2019 school year.
- Submit a separate application for each student. Remember to sign and date the application as unsigned applications cannot be accepted. Return completed application to:

- · State law does not allow students to ride a bus until their application is approved and the student is assigned to a specific bus route. Parents are required to provide transportation until notified by Transportation Services that their application has been approved.
- Transportation Services cannot assign students to a bus that would exceed bus capacity. Poudre School District bases bus capacity on age group and size of bus. If the student load exceeds bus capacity, students with The Boys & Girls Club transportation will be removed from the bus in order to make space available for students who require transportation to their home address. If it does become necessary to remove the student based on bus capacity, you will be notified three days before your student is removed from the bus.
- The Boys & Girls Club Transportation Application is good for one school year. Parents must submit a new application each year.
