If your student attends the Boys & Girls Club after school, you may submit this application to request transportation from your student's school to the Boys & Girls Club. (There may be other reasons to request alternative transportation such as daycare, split families, etc. In these cases parents may apply for alternative transportation by completing the *Alternative Transportation Request Form.*) Be sure to read the information below, carefully.

Please note: Transportation to the Boys & Girls Club is only available from certain schools. Transportation is not provided from the Boys & Girls Club to the student's home or other location.

## Application Process and Timeline

- All requests are processed first-come, first-served and are based on the space available on existing routes. (Note: Transportation Services cannot change bus stops or routes in order to accommodate requests.)
- Transportation Services will accept applications beginning June 1, 2019, for the 2019–2020 school year.
- Submit a separate application for each student. Remember to sign and date the application as unsigned applications cannot be accepted. Return completed application to:
