MEDICAL PREMIUM DISCOUNT REQUIREMENTS

STEP 1: KNOW YOUR NUMBER HEALTH ASSESSMENT

DEADLINE: JUNE 30, 2025

Know Your Number (KYN) is an evidenced-based health risk assessment and education tool, which evaluates your individual risk for six (6) of the most costly, modifiable chronic diseases, including Diabetes, Coronary Heart Disease (CHD), Stroke, Congestive Heart Failure (CHF), Chronic Obstructive Pulmonary Disease (COPD), and Lung Cancer. A simple report displays your disease risk and a peer risk comparison. The primary focus of the Know Your Number Assessment is to identify your modifiable disease risk, or the risk that can be minimized with changes to behaviors and healthier lifestyle choices.

Complete the assessment by selecting the Know Your Number Assessment event title from the homepage or via the menu page. Complete all questions, except for the Health Metrics section. Wellworks will upload your screening results once you complete an Annual Biometric Screening (see step STEP 2).

- If your health metrics have already been entered, complete the questionnaire, and click Finish to submit your responses.
- If your health metrics have not been entered, complete the questionnaire, and click Save. The assessment will be completed once your metrics are entered by Wellworks For You.

Once your assessment is completed in its entirety (questionnaire and health metrics), your results report will be generated and available on the Know Your Number (KYN) Assessment page of the Wellness Portal, as well as uploaded to the Wellness Locker under the Health Records section. Your participation in the assessment will also be updated at this time.

STEP 2: ANNUAL BIOMETRIC SCREENING

DEADLINE: JUNE 30, 2025

Complete one (1) of the options below to complete Step 2:

ONSITE BIOMETRIC SCREENING

Poudre School District will be hosting free onsite biometric screenings throughout the year. Details will be posted on the PSD Staff Website under Employee Wellness. Your results will be automatically submitted to Wellworks For You and uploaded to your Wellness account for participation.

PHYSICIAN RESULTS FORM

Visit your Primary Care Physician (PCP) for an annual physical with lab work. Print out the Physician Results Form located within the Wellness Locker, linked on the homepage or the menu page, and take it to your doctor. All required metrics must be collected between AUGUST 1, 2024, and JUNE 30, 2025 and submitted to Wellworks For You by JUNE 30, 2025 to receive credit. Please allow ample time when scheduling your annual physical, as well as time for blood work to be processed by the lab and received by your PCP's office. Do not send lab results directly to Wellworks For You. Lab results should be documented on your Physician Results Form (located in Wellness Locker) and returned to Wellworks For You.

Please Note: It is the participant's responsibility to ensure the completed form is submitted by the deadline. It is advised that you retain your own copy of the completed Physician Results Form to ensure submission to Wellworks For You.

MEDICAL PREMIUM DISCOUNT INCENTIVE

If you are currently on the PSD Medical Benefits plan you must complete Step 1: Know Your Number Health Assessment and Step 2: Annual Biometric Screening, as listed above, by JUNE 30, 2025, to be eligible for a \$25/per month medical premium discount beginning AUGUST 2025.

 Mental Health First Aid Training – Attend a Mental Health First Aid certification class between JULY 1, 2024, and JUNE 30, 2025. Upload a copy of your certification to the Wellness Portal for credit. 	10
• Physical Activity Tracking – Track at least 100 workouts for at least thirty (30) minutes in length under the Fitness and Nutrition Dashboard and Wellworks will automatically update your points once per month or submit a log of your workouts to the Wellness Portal for processing.	15
 Preventive Exams and Vaccinations – Receive credit in the Wellness Portal for each annual preventative exam and vaccination between JULY 1, 2024, and JUNE 30, 2025. Exams include two (2) dental exams per year, cervical cancer screening, prostate cancer screening, mammogram, colonoscopy, bone density screening, skin cancer screening, and an annual wellness exam with your Primary Care Doctor. Vaccinations include COVID-19, shingles, pneumonia, and/or Hepatitis B. 	5 EACH
• Race Participation - Participate in a walking, running, swimming, or bicycling event with a minimum distance of 5K. Submit proof of participation such as a confirmation email or receipt to the Wellness Portal for credit. Limit four (4) per year.	15 EACH
• Weight Management Program – Participate in at least twelve (12) consecutive weeks of a program at home, in the office, or through a physician (i.e.: Weight Watchers, Jenny Craig, Nutrisystem, etc.) and submit proof to the Portal.	20
 Wellbeats Participation – Access Wellbeats through your Wellworks app or desktop via the Fitness & Nutrition Dashboard. Play at least 80 minutes of classes each month to earn 10 points. Participation will be updated monthly. 	10
• Wellworks Wellness Challenges - There will be five (5) wellness challenges offered during the wellness year including the Better Sleep Challenge, the Holiday Saving Spree Challenge, Challenge Your Palate Challenge, the Mindful Bingo Challenge, and Don't Wait, Hydrate! 
SUBMIT YOUR COMPLETED DOCUMENTS BY JUNE 30, 2025

All forms, guides, and applicable documents are located in your Wellness Portal within the Wellness Locker accessed via the Portal MENU or homepage section. Download and/or print PDF forms for completion. All completed documents should be submitted to the Wellworks Forms Department in one (1) of the following ways:

Upload to Portal: Click the **Upload a Form** tile from the homepage or via the menu page select the event title from the dropdown and upload your form to the portal. This will be securely emailed for processing. Users are limited to one (1) file per email.

Upload to Mobile App: Take a photo of your form using your Smartphone. Next, upload it to the Wellworks For You Mobile App via the Contact Us/Send a Form tab in the menu. located in the top left corner of the home screen.

THE FINE PRINT

The Poudre School District wellness program is a voluntary wellness program available to all employees. The program is administered according to federal rules permitting employer-sponsored wellness programs that seek to improve employee health or prevent disease, including the Americans with Disabilities Act of 1990, the Genetic Information Nondiscrimination Act of 2008, and the Health Insurance Portability and Accountability Act, as applicable, among others. If you choose to participate in the wellness program, you will be asked to complete a voluntary health risk assessment, Know Your Number, that asks a series of questions about your health-related activities and behaviors and whether you have or had certain medical conditions (e.g., cancer, diabetes, or heart disease). You will also be asked to complete a Biometric Screening with Lab Work, which will include a lipid panel/glucose blood test and body measurements. You are not required to complete these components. However, employees who choose to participate in the wellness program will receive a \$25/per month medical premium discount beginning August 2025. All PSD employees, regardless of benefit status, are eligible to participate in various wellness activities and earn points to be entered into raffle drawings for cash prizes.

If you are unable to participate in any of the health-related activities or achieve any of the health outcomes required to earn an incentive, you may be entitled to a reasonable accommodation or an alternative standard. You may request a reasonable accommodation or an alternative standard by contacting Wellworks For You at 800-425-4657.

The information from your HRA and the results from your biometric screening will be used to provide you with information to help you understand your current health and potential risks, and may also be used to offer you services through the wellness program. You also are encouraged to share your results or concerns with your own doctor.

PROTECTIONS FROM DISCLOSURE OF MEDICAL INFORMATION

We are required by law to maintain the privacy and security of your personally identifiable health information. Although the wellness program and Poudre School District may use aggregate information it collects to design a program based on identified health risks in the workplace, Wellworks For You will never disclose any of your personal information either publicly or to the employer, except as necessary to respond to a request from you for a reasonable accommodation needed to participate in the wellness program, or as expressly permitted by law. Medical information that personally identifies you that is provided in connection with the wellness program will not be provided to your supervisors or managers and may never be used to make decisions regarding your employment.

Your health information will not be sold, exchanged, transferred, or otherwise disclosed except to the extent permitted by law to carry out specific activities related to the wellness program, and you will not be asked or required to waive the confidentiality of your health information as a condition of participating in the wellness program or receiving an incentive. Anyone who receives your information for purposes of providing you services as part of the wellness program will abide by the same confidentiality requirements. The only individual(s) who will receive your personally identifiable health information are the Wellworks For You team in order to provide you with services under the wellness program.

In addition, all medical information obtained through the wellness program will be maintained separate from your personnel records, information stored electronically will be encrypted, and no information you provide as part of the wellness program will be used in making any employment decision. Appropriate precautions will be taken to avoid any data breach, and in the event a data breach occurs involving information you provide in connection with the wellness program, we will notify you immediately.

You may not be discriminated against in employment because of the medical information you provide as part of participating in the wellness program, nor may you be subjected to retaliation if you choose not to participate.
