UPDATE AND ANALYSIS OF 2015 AIR CONDITIONING STUDY RFP 23-700-002

Poudre School District (the "District") is requesting electronic proposals from professional and qualified Service Providers to perform an analysis of a 2015 air conditioning study and provide updates and recommendations as described in this Request for Proposal ("RFP").

The District shall provide copies of this RFP to Service Providers through the electronic solicitation platform www.bidnetdirect.com where registered Service Providers are required to submit their electronic RFP response along with the first and last name, telephone number and e-mail address of the employee within their organization who will be designated as the District's primary contact with respect to this RFP and their Service Provider's response thereto.

Questions regarding this RFP must be in writing and shall only be directed to the District via the BidNet platform any time after the issuance of this RFP through and including 2:00 p.m. MT on October 25, 2022. Questions received after the date/time and/or not submitted electronically through the BidNet platform may not be addressed. Each question submitted, as well as the District's response thereto, shall be provided in a questions and answers document via www.bidnetdirect.com. Note: Every question must be submitted individually. Multiple questions per entry will not be answered.

The District will only accept and consider electronically submitted proposals from Service Providers, which must be submitted and received in the www.bidnetdirect.com electronic solicitation portal on or before 2:00 p.m. MT on November 8, 2022. at which time the submission portal will close, and no further submissions be allowed or considered. It is the sole responsibility of the Service Provider to see that the proposals are submitted through the BidNet portal by the submission deadline.

Sales Prohibited/Conflict of Interest: No officer, employee, or member of the School Board, shall have a financial interest in the sale to the school district of any real or personal property, equipment, material, supplies or services where such officer or employee exercises directly or indirectly any decision-making authority concerning such sale or any supervisory authority over the services to be rendered. This rule also applies to subcontracts with the School District. Soliciting or accepting any gift, gratuity favor, entertainment, kickback or any items of monetary value from any person who has or is seeking to do business with the District is prohibited.

Collusive or sham proposals: Any proposal deemed to be collusive or a sham proposal will be rejected and reported to authorities as such. Your authorized signature on this proposal assures that such proposal is genuine and is not a collusive or sham proposal.

The District reserves the right to reject any and all proposals and to waive any irregularities or informalities.

REQUEST FOR PROPOSALS UPDATE AND ANALYSIS OF 2015 AIR CONDITIONING STUDY RFP 23-700-002

BACKGROUND

Poudre School District is a high-performing district, covering more than 1,800 square miles in northern Colorado with diverse school settings. The District's instructional program is centered around District Ends, under the Policy Governance model, developed to support a comprehensive curriculum.

While more than 70% of the District's families choose to send their children to their neighborhood school, the District does support school choice and offers a wide spectrum of educational programs to fit any child's needs. Program options include International Baccalaureate, Core Knowledge, Bilingual/Dual Language Immersion, Hybrid/Online, Expeditionary Learning, Science, Technology, Engineering and Math (STEM) along with extracurriculars and athletics. The District has two LEED certified school buildings and over 30 Energy Star awards and supports operational sustainability in all areas of work. Our Schools:

- 32 elementary schools
- 10 middle schools
- 4 comprehensive high schools
- 2 additional combined middle/high schools opening in Fall of 2022
- 6 option (100% choice) schools
- 3 alternative high schools
- 5 charter schools
- 1 online school

The District is fully accredited by the Colorado Department of Education Accreditation and Accountability Unit and is subject to periodic monitoring to ensure continued compliance with accreditation standards.

1.0 GENERAL CONDITIONS

- 1.1 Information and materials submitted in response to this solicitation may be considered public records subject to disclosure under the Colorado Open Records Act ("CORA"), C.R.S. §§ 24-72-200.1 to -205.5. Information and materials that Service Provider believes are confidential and not subject to disclosure under CORA must be submitted separately with a citation to the section of CORA and any other relevant law under which Service Provider believes they are confidential. The District, not Service Provider, shall determine whether information and materials so identified will be withheld as confidential, but will inform Service Provider in advance of disclosure to give it an opportunity to take legal action to protect its interests vis-à-vis the party making the CORA request.
- 1.2 This is a solicitation for an offer and is not an offer to contract for goods or services.
- 1.3 Service Provider must provide all requested information. Failure to do so may result in rejection of the proposal at the option of the District.
- 1.4 Proposals must meet or exceed specifications contained in this document.
- 1.5 The District is exempt from city, county, state, and federal sales/excise taxes. Tax exempt certificates will be issued upon request.
- 1.6 Submission of a proposal is deemed as acceptance of all terms, conditions and specifications contained in the District's solicitation package initially provided to the Service Provider. Any proposed modification must be accepted in writing by the District prior to award of the contract.
- 1.7 Each Service Provider, its employees, representatives, and subcontractors, agrees to abide by all applicable federal, state, and local codes, laws, rules and regulations.
- 1.8 The successful Service Provider shall furnish all supplies, which conform to all applicable safety codes and regulations.
- 1.9 Contact with District personnel regarding this RFP, other than inquiries to the specific Procurement Agent identified in this document, may be grounds for elimination from the selection process.
- 1.10 Proposals shall contain a signature of an authorized representative in the space provided on the Proposal Certification Form. Failure to properly sign the proposal may invalidate same and it may not be considered for award.
- 1.11 The accuracy of the solicitation is the sole responsibility of the Service Provider. No changes in the proposal shall be allowed after the submission deadline, except when the Service Provider can show clear and convincing evidence that an unintentional factual mistake was made, including the nature of the mistake.

- 1.12 For services requiring Service Provider's presence on District property and the project site(s), the Service Provider must provide proof of insurance that meets the insurance requirements stated in Section 6.0 of this document.
- 1.13 Health and Safety Standards. The Service Provider shall have and maintain a set of protocols and guidelines to meet evolving health and safety requirements and implement any applicable communicable disease protocols, which must follow guidance and orders from state and/or local public health officials and be no less strict than the District's protocols.
 - 1.13.1 Service Provider shall ensure all individuals providing Services under this agreement for the Service Provider wear appropriate personal protective equipment as designated in this section 1.13, at all times while on District property.
 - 1.13.2 If the District is directed, or the District determines to limit or restrict access to any or all of its facilities or District Location due to a public health or safety concern, the District may, at its discretion, temporarily delay or stop Service Provider's services, with or without prior notice.
- 1.14 The successful Service Provider is not permitted to transfer any interest in the project whether by assignment or otherwise, without prior written consent of the District's Strategic Sourcing Department.
- 1.15 Service Providers are required to complete the Reference Form included in this solicitation as described.
- 1.16 Service Provider must note in the solicitation response any intent to use subcontractors. The subcontractor's name, address, phone number and three client references, along with the type of work to be performed must be included. Use of subcontractors may be considered as a factor in the District's evaluation process. If the Service Provider fails to notify the District of its intent to use subcontractors in the proposal submittal, the proposal may be considered a void offer. Subcontractors will be allowed only by written permission of the District. The Service Provider agrees that it is fully responsible to the District for the acts or omissions of its subcontractors, or any persons employed by them, in the same way as it is for the acts and omissions of persons directly employed by the Service Provider. Nothing contained in the contract, or any subcontract shall create any contractual relation between any subcontractor and the District.
- 1.17 The District reserves the right to reject any and all proposals or any part thereof, to waive any formalities, and further, to award the proposal to the responsible Service Provider as deemed in the best interest of the District.
- 1.18 There is no expressed or implied obligation for the District to reimburse responding Service Providers for any expenses incurred in preparing proposals in response to this request.

- 1.19 Responses to this solicitation will be independently evaluated by an evaluation committee to be established for such purpose.
- 1.20 Proposals submitted will be evaluated using pre-determined objective rating criteria. Those that are clearly non-responsive to the stated requirements may be eliminated prior to the evaluation. Prior to proposal submission, Service Provider are encouraged to check the BidNet website to ensure additional requirements are incorporated into its submissions.
- 1.21 The District reserves the right to negotiate further with one or more Service Providers or to request additional information. The District may make such inquiries and conduct such investigations as it deems necessary to determine the qualifications and ability of the Service Provider to provide the services called for under the RFP and/or represented in the Service Provider's response. Service Providers shall timely provide information to the District in connection with such inquiries and investigations. Service Providers may be asked to give presentations to the District regarding their proposals.
- 1.22 Should the District determine, in its sole discretion, that only one Service Provider is fully qualified or that one Service Provider is clearly more highly qualified than the others under consideration, a contract may be negotiated and awarded to that Service Provider.
- 1.23 The Service Provider shall not utilize any laborer or employee who has been convicted of a violent crime or a crime of such nature (e.g., child related offenses) as to categorize the person as being unsuitable for working around school children or has engaged in such conduct as to be similarly categorized. In the event the District has reasonable grounds to believe that any individual assigned to perform work under this Agreement has a criminal record, is a registered sex offender, has exhibited violent behavior or is under the influence of alcohol or an illegal substance, including marijuana, while performing the Services or based upon other information the District deems reliable, the District may exclude such individual from any District property or impose reasonable conditions upon such individual's presence at any District Location unless the Service Provider submits a copy of a completed security/background check on the employee. In the judgement of the District, if the Services cannot be performed as a result of such action, the Agreement may be terminated. Removal of a specific person(s) will not relieve the Service Provider from timely performance of work completion and will not be considered grounds for a request for additional funds or time extension to complete the Services.
 - 1.23.1 The Service Provider, its laborers and employees shall not fraternize or otherwise communicate with any District students except in cases of safety and like necessities.
- 1.24 The District intends for the contract to commence upon complete execution of a successfully negotiated agreement and continue in full force and effect through and including June 30, 2024, unless earlier terminated by the District as provided

- in Section 1.27 below. The final award and contract start date is contingent upon a successfully negotiated and fully executed contract between the District and the recommended Service Provider. The intended date is provided for planning purposes only.
- 1.25 For services provided, and at the option of the District, the agreement may be extended beyond the first term for up to four (4) additional one-year terms, subject to the parties' negotiation of mutually agreed upon amendments to the Agreement for each one (1) year term. Pricing will remain fixed and firm for the initial term and all extensions of the agreement.
- 1.26 Notwithstanding any other term or provision of this Request for Proposal, the District's obligations hereunder are expressly subject to its budgeting and appropriation of sufficient funds for each fiscal year (July 1 June 30) a contract is in effect. In no event shall the District's obligations in a contract constitute a multiple-fiscal year direct or indirect debt or other financial obligation under Article X, Section 20(4)(b) of the Colorado Constitution.
- 1.27 Notwithstanding the other provisions of this RFP, either party may terminate this Agreement at any time in that party's sole discretion for any reason, with or without cause, by providing the other party with thirty (30) days' advance written notice. In the event of such termination: (a) the District shall pay Service Provider for all Services performed under and in accordance with this Agreement up to the date of termination; and (b) Service Provider shall reimburse the District for all payments made in excess of Services performed up to the date of termination.
- 1.28 The Service Provider shall provide the services as an independent contractor of the District. As such, the Service Provider shall have the right to determine how and by whom the services will be provided, subject to and consistent with the terms and conditions of this solicitation.
 - 1.28.1 The Service Provider shall be exclusively responsible for: (a) all compensation, employment tax withholdings and payments, and all fringe benefits for its employees in full compliance with all applicable federal, state and local laws; (b) all insurance coverages and benefits for its employees in full compliance with all applicable federal, state and local laws, including but not limited to pension or retirement benefits, workers' compensation, unemployment compensation, and Social Security benefits; and (c) all payments to its suppliers and subcontractors for goods and/or services directly or indirectly related to this solicitation.
 - 1.28.2 Nothing in this solicitation or as a result of this solicitation shall be construed as creating a single enterprise, partnership, joint venture or employer-employee relationship between a future Service Provider and the District. The future Service Provider will not be considered a partner, agent or representative of the District and will not represent itself to be a partner, agent or representative of the District. The District is not a

partner, agent or representative of any future Service Provider and shall not represent itself to be a partner, agent or representative of the Service Provider.

1.29 Qualifications of Service Provider

- 1.29.1 The District may make such reasonable investigations as deemed proper and necessary to determine the ability of the Service Provider to perform the work and the Service Provider shall furnish to the District all such information and data for this purpose as may be requested.
- 1.29.2 The District further reserves the right to reject any proposal if the evidence submitted by, or investigations of, such Service Provider fails to satisfy the District that such Service Provider is properly qualified to carry out the obligations of the contract and to complete the work/furnish the item(s) contemplated therein.

1.30 Miscellaneous

- 1.30.1 Once the evaluation is complete and the Intent to Award has been issued to the recommended Service Provider, the recommended Service Provider will work with the District's Contract Administrator to successfully negotiate an agreement.
- 1.30.2 Governing Law and Venue. All issues regarding the formation, performance and/or legal enforcement of the Contract shall be governed by and construed in accordance with the laws of the State of Colorado. Venue for the resolution of any disputes arising out of or relating to the Contract shall be in Larimer County, Colorado.
- 1.30.3 Equal Opportunity. It is agreed that no otherwise qualified Service Provider shall be excluded from participating in, be denied the benefits of, or be subject to discrimination, including harassment, under any provision of this Agreement on the basis of race; creed; color; national origin; age; sex; pregnancy; physical recovery from childbirth or a related condition; sexual orientation; marital status; veteran status; religion; genetic information; gender expression; gender identity; ancestry; or disability.
- 1.30.4 Appeal of Award. The Service Provider may appeal the award by submitting, in writing, a request for re-consideration to the District's Executive Director of Finance within seventy-two (72) hours after the receipt of the notice of award.
- 1.30.5 In the event the awarded Service Provider defaults on its contract or the contract is terminated for cause due to performance, the District reserves the right to re-procure the Services from the next lowest Service Provider or from other sources during the remaining term of the terminated/defaulted contract. Under this arrangement, the District shall

- charge the awarded Service Provider any differences between its price and the price to be paid to the next lowest Service Provider, as well as, any costs associated with the re-solicitation effort which resulted from such default or termination.
- 1.30.6 This solicitation does not commit the District to award a contract or to pay any costs incurred in the preparation of a proposal or to procure a contract for the services. The District reserves the right to accept or reject any or all proposals received as a result of this request or to cancel in part or in its entirety this solicitation if it is deemed to be in the best interest of the District. The District reserves the right to accept any portion of the proposal, or the entire proposal as deemed in the best interest of the District.
- 1.30.7 For the purposes of solicitation evaluation, Service Provider must indicate any variances to the specifications and terms and conditions, no matter how slight. If variations are not stated in the Service Provider's response, it shall be construed that the proposal fully complies with the specifications and terms and conditions. Notwithstanding the above, it is hereby agreed and understood that the District reserves the right to reject these variations if they individually or, as a whole, do not meet the standards established in the specifications. Modifications to this RFP document and/or exhibit will not be considered valid and may be cause for disqualification. Award of this solicitation does not constitute the District's acceptance of the Service Provider's proposed variations.
- 1.30.8 Sustainability. The District is committed to be a responsible steward of our natural resources and believes that public education should provide leadership in developing an ethic of sustainability in all its practices. In the District we have both Energy Conservation and Waste Management policies and espouse these values, making environmental stewardship and integral part of the physical plant operation.

1.31 Cooperative Purchasing Efforts

- 1.31.1 Poudre School District is a member of, or affiliated with, several regional professional procurement organizations within Colorado and Wyoming. These organizations are comprised of governmental purchasing agents, or agency representatives responsible for the purchasing function.
- 1.31.2 These organizations include:
 - 1.31.2.1 Colorado Educational Purchasing Council (CEPC) A cooperative purchasing organization comprised of purchasing agents/buyers representing all Colorado public school districts.
 - 1.31.2.2 Multiple Assembly of Procurement Officials (MAPO) A cooperative purchasing organization comprised of procurement

representatives from state, county, municipal, governments, special districts or school districts along the front range of the Rocky Mountains in Colorado.

- 1.31.2.3 Rocky Mountain Governmental Purchasing Association (RMGPA) A chapter member of the National Institute of Governmental Purchasing (NIGP), consisting of public procurement professionals and their representative agencies which include approximately 100 state, county, and municipal governments; school districts and higher education; and other special districts.
- 1.31.3 Members of these organizations, at their discretion, may request use of the contracts or awards that result from this solicitation. Each governmental entity which uses a contract(s) resulting from this solicitation would establish its own contract, issue its own orders, schedule deliveries, be invoiced individually, make its own payments, and issue its own exemption certificates as required by the Service Provider. It is understood and agreed that Poudre School District is not a legally binding party to any contractual agreement made between another governmental entity and the Service Provider as a result of this solicitation. The District shall not be liable for any costs or damages incurred by any other entity. Usage by any other entity shall not have a negative impact on the District in the current term or in any future terms.

2.0 SCOPE OF WORK AND REQUIREMENTS

The District is seeking a professional and qualified Service Provider to perform an analysis of a 2015 air conditioning study and provide updates and recommendations including but not limited to the deliverables described herein.

In 2015, the District commissioned a comprehensive study to determine the requirements for providing air conditioning to all District schools that did not have air conditioning. In addition, the study also provided some investigation into how we can improve schools that had air conditioning that were not performing well. The desired outcome of the study was to define the estimated investment to provide air conditioning to all schools.

At that time, the District retained the services of Horsetooth Engineering to complete the 2015 Air Conditioning Study. This study is attached as Exhibits A, B, C, D, and E. The District desires to update this 2015 study to take into consideration improvements that have been completed, additional system degradation, and the addition of new schools. The Service Provider will also be required to consider new bell times established since 2015 and account for additional heat days resulting from earlier school start times.

Definition: "Opinion of Probable Cost" is defined as an estimation of costs based on the professional's experience and qualifications that represent the professional's best judgement as an experienced and qualified professional in their field and familiarity with the construction field.

2.1 Evaluate Mechanical Concepts

- 2.1.1 Work with District staff (HVAC, Controls, and Construction personnel) to confirm the inventory of equipment and controls reported in the 2015 Air Conditioning Study. Service Provider must consider improvements/upgrades to schools completed since 2015 and update the inventory accordingly.
- 2.1.2 Review the assumptions and recommended options in the 2015 study to provide air conditioning in each school currently without air conditioning and to improve the air conditioning in schools with poor performing systems. Revise previous recommendations based upon new technologies and work completed since 2015.
- 2.1.3 Provide in narrative form and notes on CAD floor plans the updated concepts for equipment, duct and piping installation in each school.
- 2.1.4 Coordinate with a mechanical contractor to assist in establishing an Opinion Of Probable Cost for projects at each location.
- 2.1.5 Provide narratives and CAD plans to architectural, structural, and electrical consultants so the impact of the mechanical system installation on other building systems can be analyzed.
- 2.1.6 Review the assumptions and recommended options in the 2015 study for improvement of the existing dedicated outdoor air systems ("DOAS").
- 2.1.7 Provide updated conceptual narrative for improvement of the existing DOAS.
- 2.1.8 Coordinate with a mechanical contractor, as well as architectural, structural, and electrical consultants for costs and impacts of updated strategies to improve the existing DOAS installations.
- 2.1.9 Provide in narrative format, suggestions for efficiency and/or performance improvement of existing schools with air conditioning.
- 2.1.10 Provide updated cost estimates in 2023 dollars for all recommendations whether new concepts or concepts carried forward from the 2015 study.
- 2.2 The successful Service Provider shall conduct site visits for those schools that require more in-depth review of existing conditions.
- 2.3 Architectural Impacts
 - 2.3.1 Service Provider's architectural consultant shall review the mechanical system impact for items such as roof penetrations, wall penetrations, ceiling removal and reinstallation, roof patching and wall patching.

- 2.3.2 Provide Opinion of Probable Cost
- 2.3.3 Visit sites for select schools that are more complicated or as-built documents are not adequate.

2.4 Structural Impacts

- 2.4.1 Service Provider's structural consultant shall review mechanical system impact for items such as roof penetrations, wall penetrations, and supporting new roof mounted equipment.
- 2.4.2 Provide Opinion of Probable Cost for projects at each location.
- 2.4.3 Visit sites for select schools that are more complicated or as-built documents are not adequate.

2.5 Electrical Impacts

- 2.5.1 Service Provider's electrical consultant shall review mechanical system impact for items such as main electrical service size replacement and/or addition, power feeds to new equipment, and removal of old equipment.
- 2.5.2 Provide Opinion of Probable Cost for projects at each location.
- 2.5.3 Visit sites for most schools some "prototypical" schools such as Dulaney models may not all be visited.
- 2.5.4 Service Provider shall also work with their electrical consultant to provide an Opinion of Probable Cost for upgrading to LED light fixtures while the mechanical systems are being replaced.

2.6 Mechanical

- 2.6.1 Coordinate with a mechanical contractor for systems concepts at schools and provide budget estimates based on historical costs of similar systems and previous work for the District
- 2.6.2 Coordinate with equipment vendors for budget pricing on large equipment.
- 2.6.3 Visit sites as needed for more complex schools.
- 2.6.4 Assist with development of Opinion of Probable Cost for each location as if work were to be completed in 2015/16.
- 2.7 The Service Provider shall plan on several meetings with District management, including, but not limited to:

- 2.7.1 One (1) meeting for the purpose of kicking off the project.
- 2.7.2 One (1) meeting after completion of initial analysis and reconciliation of changes completed since 2015.
- 2.7.3 One (1) meeting to present concept studies for recommended changes to the concepts included in the 2015 study.
- 2.7.4 One (1) meeting at completion of initial work. Discuss findings, recommendations, and estimated costs.
- 2.7.5 One (1) meeting as follow up discuss issues that surface from study report review.

3.0 COST PROPOSAL

- 3.1 The Service Provider's cost proposal shall clearly state the not to exceed fee for this service.
- 3.2 The stated fee shall cover any and all costs incurred by the Service Provider for this project as stated in this RFP.

4.0 EVALUATION AND AWARD OF CONTRACT

The District intends to award the contract to one (1) Service Provider for this service; the District reserves the right to award services to multiple Service Providers if deemed in the best interest of the District. The District also reserves the right to utilize other services in conjunction with the awarded Service Provider(s) program if deemed in the best interest of the District. Those proposals that are clearly non-responsive to the stated requirements may be eliminated prior to evaluation.

- 4.1 The following criteria will be considered by the evaluation committee when reviewing proposals. The order of the criteria noted below does not indicate order of importance.
 - 4.1.1 Relevant and detailed information presented in the proposal that demonstrates ability to meet requirements in the Scope of Work and Requirements section of this solicitation.
 - 4.1.2 Ability of the Service Provider to provide quality and timely services to meet the District's needs.
 - 4.1.2.1 Appropriate number of staff assigned to the project who are adequately qualified to conduct and supervise the work.
 - 4.1.3 Qualifications and experience of the Service Provider.
 - 4.1.4 Cost(s) of services.

- 4.1.5 Service Provider's capacity to complete the project on time.
- 4.1.6 Reference checks, as necessary.
- 4.2 The District may at its discretion, elect to interview one (1) or more Service Providers that submit a proposal, but is not required to do so. The interview may either be conducted via a virtual platform or in person at a Poudre School District location (Ft. Collins, Colorado).
 - 4.2.1 The determination of whether to conduct interviews with the finalist(s) shall be made by the District based solely on its determination of whether interviews would be helpful in evaluating the proposals.
 - 4.2.2 Any Service Provider selected for an interview will be expected to make an introductory presentation followed by a question and answer period. The District will not reimburse any travel related or other expenses related to an interview.
