6.0 SUPERINTENDENT REPORT

Superintendent Kingsley introduced a video highlighting student art with responses to "Art Is" and said we have a lot to learn from students if we just listen to them, spoke about recent school visits, acknowledged mental health awareness month and addressed a magical collaboration across the district to support mental health needs, thanked community partners and district staff for collaborating around services for families and students, and talked about the upcoming budget update that will inform the community about how we are developing our budget.

7.0 COMMUNITY COMMENT

Eric Sutherland said there is an imminent recession due to an unhelpful cult that is running the country and asked the district to have more respect for people who pay taxes.

Lorrie Maggio-Huber spoke on behalf of district media specialists and said school libraries are understaffed, underfunded, and underappreciated.

Cain Young asked listeners to take their children out of government schools and expressed concern about various books available in school libraries.

Judy Papenfuss shared her belief that public schools damage students and said there are too many unnecessary staff such as SEL teachers, counselors, DEI, etc.

Sabrina Herrick informed listeners she is running for the Board of Education in District C.

Anna Lebedda asked the Board to move their position on SB 25200 from 'monitoring' to 'supporting' for dyslexia support.

Dani Lawrence said the district continues to strip away rights of the vulnerable disabled student population and offered multiple examples.

- School-based Budgeting is complete for next year.
- Compensation Plan process was explained.

- Grant Funding increases were clarified.
- Federally funded grants are monitored by staff; important to understand fundamentals of different grants.
- Uncertainty of State funding requires constant observation.
- Gratitude was expressed for the thorough and informative presentation.
